This agreement is subject to change and may be modified from time to time with verbal, written, fax, or email consent by both the Merchant and QFN. This agreement is perpetual and will continue until terminated. This agreement may be terminated at any time by the Merchant with written notice by fax or email to QFN.

This agreement authorizes QFN to re-price fuel transactions for all members of QPN at any location operated by the Merchant and agreed to by QFN. This agreement also authorizes WEX/FleetOne to re-price fuel transactions for all members of QPN at any location operated by the Merchant. WEX/FleetOne will remit to the merchant the re-priced transaction amount in accordance with the terms of the Merchant Service Agreement between WEX/FleetOne and the Merchant. Transaction fees are assessed by WEX/FleetOne, not QFN.

The re-priced transaction amount is calculated daily by QFN according to the re-pricing agreement addendum, which may be revised from time to time with written, fax, or email consent by both Merchant and QFN. The Merchant is responsible for notifying QFN when freight costs and/or local taxes may change.

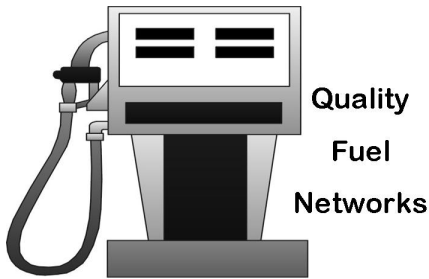

WEX/FleetOne will remit to the merchant the re-priced transaction amount in accordance with the terms of the Merchant Service Agreement between WEX/FleetOne and the Merchant. Transaction fees are assessed by WEX/FleetOne, not QFN.

The re-priced transaction amount is the better of [a] the cost-plus price or [b] the posted cash price less the cents-off discount, whichever is lower. The cost-plus price is calculated by QFN based on OPIS Contract Rack Averages for the previous business day plus freight, applicable taxes, and the cost-plus fee [Merchant's margin] as agreed to by the Merchant and QFN. QFN will calculate the daily cost-plus price and transmit the price and minimum discount to WEX/FleetOne for each fuel stop. Any pricing issue or discrepancy must be addressed first with QFN.
